efficacy of a new minimally invasive surgical technique for  
treatment of recurrent dislocation of the temporomandibular  
joint (TMJ) in which a closed reduction is performed, followed  
by splint therapy for at least 3 months, and to assess the  
clinical outcomes for all these patients. Twenty-eight joints  
in 28 patients with recurrent dislocation of the TMJ  
(recurrent group) were evaluated by means of a questionnaire,  
clinical examination, and radiological examination. All  
patients had been treated by means of closed reduction under  
general anesthesia. These patients were followed for a minimum  
period of 3 years (range, 3 to 6 years). The questionnaire  
results showed significant improvement in chewing, sleep, and  
jaw function for all these patients. The maximum incisal  
opening (MIO) was increased significantly. All patients  
reported a significant decrease in the pain they experienced.  
The postoperative CBCT imaging showed a significant reduction  
in the joint space for the majority of joints (28/28). A novel  
minimally invasive surgical technique for the treatment of  
recurrent dislocation of the TMJ was found to be effective in  
reducing pain, as well as in increasing the MIO and improving  
chewing, sleep, and jaw function.News Portsmouth's diocese has
